Resolution No. 1-18 – Environmental Stream Funding of the Agricultural Service Board Grant **Grade: Accept in Principle**

- Response states no change can be made until next agreement
- Funding can't be released until April 1st, so further discussion is needed as to whether it will make any difference

Resolution No. 2-18 – Appeals to the Minister under the *Weed Control Act* and *Agricultural Pest Act*

Grade: Incomplete

• Government has committed to a review process of timelines but no timeline has been given

ACTION ITEM: Steve made a motion to write a letter to AF to get an idea of the timelines for this review – CARRIED

Resolution No. 4-18 – Weed Control on Alberta Vacant Public Lands within Green Areas **Grade: Incomplete**

- Hearing funds are being committed but not staff
- Comprehensive framework asked for in resolution was not addressed ACTION ITEM: Merrill made a motion to write a letter to Environment and Parks and thank them for money committed. Also ask which staff to contact regarding the funding if weeds are identified and also how the framework will be rolled out and who will be identifying the weeds ie. landowners or ASBs.

Resolution No. 5-18 – Wildlife Predator Compensation Program Enhancement **Grade: Accept in Principle**

- Need to see what additional resources are going to be
- Resolution was basically answered as it asked for trained Municipal Problem Wildlife and response indicated no additional staff were being trained

Resolution No. 6-18 – Review of Agriculture Financial Services Corporation (AFSC) Crop Insurance Program

Grade: Incomplete

Committee felt resolution was not answered
 ACTION ITEM: Set up a meeting with AFSC to discuss these issues as there is too much information required to put in a letter

Resolution No. 7-18 – Crop Insurance for Alberta Fruit Producers

Grade: Incomplete

Resolution No. 9-18 – Farm Direct Marketing of Eggs and Products using Eggs Grade: Accept in Principle

- Question has been answered may not like it but was answered
- A review is mentioned but nothing has happened yet ACTION ITEM: Doug is to request information as to when the review will take place

Resolution No. 10-18 – Proposed Federal Tax Changes Grade: Accept

• Many of the concerns have been reversed so the resolution has been answered

Resolution No. 11-18 – Organic Food Testing and Labeling **Grade: Accept in Principle**

- AF indicated it was working on the intra-provincial gap
- New act is being developed
- Provincial Committee would like to be part of the consultation process **ACTION ITEM:** Doug is going to find out what kind of consultation will be done on the development of the new Act.

(b) Peace Region GM Alfalfa Bylaws

- Sebastien briefed the Committee on the Peace Regions effort to elevate GMO Alfalfa
- Two letters were sent to the Minister and both declined
- Sebastien wanted Committee to understand issues here
- Need to acknowledge situation and have more discussions so everyone is on same page
- Steve moved to accept this as information CARRIED
