- a. Carbon Tax Levy does not need to be discussed
- b. Caron Tax Levy letter from S. Todd Beasley Pat talked about the letter received but nothing to discuss with Deputy Minister
- c. Bovine Tuberculosis Maureen stated there is lots of information on her Google site nothing to discuss with Deputy Minister
- d. BSE Committee to ask the Deputy Minister if the number of cattle to be tested has changed. The Minister mentioned this at the August meeting with the Committee.
- e. Clubroot/Fusarium Committee to ask the Deputy Minister about AFSC saying that producers could use 5% infected cereals for seed
- f. Elk issues Will discuss with the Deputy Minister
- g. Ag Plastics Don't feel they need to discuss with the Deputy Minister
- h. Bill 6 Committee to state they would like second round of consultation before it goes public
- i. Grant agreements Committee to raise issue of needing more funding for the ASB Program. Advise her the program was to be reviewed every 5 years and hasn't been done since 2005.
- j. GMO alfalfa will tell Deputy Minister that they don't want GMO alfalfa in Alberta and do not want co-existence plan to be developed with Ontario where they have GMO alfalfa
- k. 2016 Resolution Follow Up:
  - Assistance in Developing Relationships with other Ministers Pat to thank DM for good working relationship Committee has with AF
  - Agricultural Service Board Grant Funding and Program Review request a review of ASB program and increase funding for ASB program
  - Agricultural Pest Act Ask if timeline for review is still in place and resolutions passed regarding Act be part of the review
  - Fusarium Graminearum (FG) & FG Management Plan Steve to request update
  - Enforcement of Acts to relate this to Ag. Pest Act discussion
