Regulatory Updates

Safe Food for Canadians Regulations Officially Published in Canada Gazette Part II

On June 13, 2016, final Safe Food for Canadians Regulations were published in Canada Gazette, Part II (CGII).

The regulations will come into force on January 15, 2019. The period between the final publication of the regulations in CGII and coming into force will give businesses time to familiarize themselves with and prepare for the new requirements, including licensing, traceability and preventive controls. Some requirements will have to be met immediately upon coming into force, while others will be phased in over a period of 12 to 30 months based on food commodity, type of activity and business size.

The new consolidated regulations will require food businesses that import or prepare food for export or to be sent across provincial or territorial borders to have licences, as well as preventive controls that outline steps to address potential risks to food safety. They will also help reduce the time it takes to remove unsafe food from the marketplace by requiring businesses to trace their food back to their supplier and forward to whom they sold their products.

Proposed Regulatory Changes to Canada's Beer Compositional Standards

The Canadian Food Inspection Agency (CFIA) is proposing to amend the beer compositional standards under the Food and Drug Regulations (FDR). The proposed changes would modernize the current beer standard to remove duplication of the standard for ale, stout, porter and malt liquor, as it allows for the same ingredients as beer. The amended FDR would make it clearer for brewers which ingredients could be used. It would also allow industry to be more innovative in developing products to meet consumer interest in having more variety, such as flavoured beers, while maintaining the beer integrity.

In addition to meeting consumer interest in having more products variety, the proposed changes to the FDR also include labelling changes that would require brewers to identify food allergens, gluten sources or added sulphites for beer.

Consumers, industry and other stakeholders have 90 days to submit their comments to the CFIA. For more information, please consult the CFIA website.
