A BYLAW OF MOUNTAIN VIEW COUNTY IN THE PROVINCE OF ALBERTA TO DECLARE WILD CARAWAY AS A NOXIOUS WEED

AMENDING BYLAW NUMBER 25/10

SECTION 1 - SHORT TITLE AND PURPOSE

- 1.01 WHEREAS, the Council of Mountain View County has the authority under Weed Control Regulation, AR 19/2010 Section 9 of the Weed Control Act of Alberta to make bylaws designating plants within the County as noxious weeds, and
- 1.02 WHEREAS, Wild Caraway is a concern in hay lands, pasture and natural environments because domestic or wild animals graze around this plant causing it to spread rapidly, and
- 1.03 WHEREAS, Wild Caraway is not on the Provincial Weed List as a noxious weed and therefore, the County can not enforce its control, and
- 1.04 WHEREAS Wild Caraway has been found in several parts of the County and control measures have had marginal success,

SECTION 2 - ENACTMENT

- 2.01 NOW THEREFORE the Council of Mountain View County, in the Province of Alberta, duly assembled enacts as follows:
 - a. That Wild Caraway be designated as a noxious weed within Mountain View County as per Weed Control Regulation, AR 19/2010 Section 9.

SECTION 3 - EFFECTIVE DATE

3.01 This Bylaw shall come into effect at such time as it has received third (3rd) reading and has been signed in accordance with the *Municipal Government Act*.

1. Definitions

1.1 "Northern Pocket Gopher" a 20cm long burrowing rodent with a large head, small eyes and ears, stout body, thick muscular forearms with long curved claws, and a short nearly naked tail. The fur is fine and soft usually steel grey on the back and slightly paler on the belly.¹

1.2 "Youth" resident of Mountain View County below the age of 18.

2. Incentive Program

- 2.1 Where Northern Pocket Gophers are causing a problem on private Agricultural lands, Mountain View County is offering a trapping incentive of \$100 for 100 tails submitted by the first 50 Mountain View County youth. Multiple youths from one residence may combine their submission to reach the required program tail threshold.
- 2.2 The entire tail needs to be of good quality and frozen, preferably, for identification purposes. If a tail cannot be identified as a Northern Pocket Gopher, it will not be eligible for the incentive payment.
- 2.3 This incentive is available to Mountain View County residents only, and to Northern Pocket Gophers trapped on Mountain View County Agricultural Lands only, the legal land location of where the pocket gophers were trapped must be provided to receive the incentive.
- 2.4 Only one submission for the incentive may be made per year per residence or individual youth.
- 2.5 Mountain View County Council will establish an annual budget for the incentive trapping program for the Northern Pocket Gophers each year.
- 2.6 The program will commence April 1st and run through till the 50 submissions are made at which time no further tail submissions will be accepted and no further incentive payments will be made.
- 2.7 Agricultural Services is responsible for administering this program, and will authorize payments at their discretion.
- 2.8 This incentive program does not apply to the Richardson's Ground squirrel commonly known as gophers, or any other rodent.
