Healthy and Enhanced Meat Research: Industry Stakeholder Needs Assessment Survey

The purpose of this survey is to better understand the meat processing industries interest, position and practice of developing healthy and enhanced meat products. The results help us to better understand what individual stakeholders, organizations, and its members are doing in the area of healthy and enhanced meat processing, and what they would like to do in the future. From the survey, industry stakeholders demonstrated there is a desire to innovate in healthy and enhanced meat processing, and have also indicated their future interests, current and future priorities and related concerns. This insight shows real opportunity for Agriculture and Forestry (AF) to build on the momentum of desired change and generate collaborative projects with industry through improved awareness and understanding of the work that AF, and specifically the Food Processing Development Centre has to offer through the full value chain. Regulatory Updates

Health Canada Request for Data on Partially Hydrogenated Oils in the Canadian Food Supply

Health Canada has published a <u>request for data</u> as they conduct an on-line consultation to gather information regarding partially hydrogenated oils in the Canadian food supply. They would like to learn the amounts used, reasons for their continued use and levels of trans fat within them in an effort to eliminate the levels of industrially produced trans fats in processed foods. Industry sectors that they are calling upon to participate include manufacturers, retailers, importers, restaurants and food service suppliers and operators.

US Nutrition Facts Label Update

On May 27, 2016 the United States (US) Food and Drug Administration (FDA) published a final rule updating the Nutrition Facts label used for conventional foods and dietary supplements. This is the US's first update to nutritional labels in more than two decades. The most notable changes include the addition of an "added sugars" line, an updated list of nutrients that are required or permitted to be declared and modified serving size regulations.

Food and beverage manufacturers with sales greater than \$10 million will be required to begin using the new label by July 26, 2018; companies with less than \$10 million in annual food sales will have an additional year to comply (i.e., July 26, 2019). This rule will apply nationally and to all imports entering the U.S.
