<p>Green Certificate Refund Policy</p> <p>Schools registering students in Green Certificate that have an Alberta student number will not be charged a registration fee by Alberta Agriculture and Forestry effective September 1, 2017; therefore, the refund policy will not apply to these schools.</p> <p>Schools registering students in Green Certificate without an Alberta student number whom withdraw from the Green Certificate Program may be eligible for a refund.</p> <p>Schools with trainees registered before September 1, 2017 may be eligible for a refund.</p>	3.01, 3.02, 2.06, 5.01

- Prior to September 1, 2017, Alberta Agriculture and Forestry charged Alberta high schools/school jurisdiction a fee for the use of the Green Certificate Training Program. The fee was used to provide the various components of the Program. In situations where a trainee withdraws from the Program, some components may not have been provided. In this case, the school may be entitled to a refund.
- Withdrawal from the Green Certificate Program must be initiated by the trainee contacting their school coordinator (See Policy 3.01 - Withdrawal Policy)
- Termination from the Green Certificate Program is initiated by the Green Certificate Program for non-compliance with Green Certificate policies. (See Policy 3.02 – Removal). If a trainee is terminated, the school is in-eligible for a refund.
- Refund amounts are based on the value of the registration fee paid at time of registration (See Policy 5.01 – Registration Fee and Invoice). The rate prior to September 1, 2017 was \$960.00 + GST. Taxes are not eligible for refund.
- Refunds are paid to the school/school jurisdiction indicated on the registration in GINA.
- Refunds will be provided on components of service delivery on the following basis:
