

Board says goodbye to well-respected Chairman, Vern Hartwell

Vern Hartwell joined the NRCB as its chair in June 2006. His appointment expires October 31, 2017. Vern will be missed by everyone who works with him at the NRCB, and by the many people who know him in Alberta's livestock industry, government, and municipalities.

The board reorganized in 2006 to better reflect the separation of board panel reviews from the regulatory responsibilities of its operational staff. Vern brought a fresh perspective, strong leadership, and, from his many years in community and economic development in central Alberta, an understanding of the challenges of agriculture and rural economies in an increasingly urban environment.

Before joining the NRCB Vern was mayor of Strathcona County for nine years and a councilor for three years. Vern also participated in numerous other leadership and committee roles, including chairing the Alberta Capital Region Alliance, the Alberta Industrial Heartland Association, and the Strathcona



County Economic Development & Tourism Committee. Vern also filled the chair position of Alberta's Surface Rights Board and Land Compensation Board from April 1, 2011 to July 31, 2013, in addition to chairing the NRCB.

Throughout his 11 years with the NRCB, Vern emphasized the importance of public transparency and accountability.

"Working with the board members and staff of the NRCB has been a great privilege and wonderful opportunity. This is a team of really dedicated and talented people. They put their hearts into making decisions that have integrity. They respect all the parties and want to make sure that their decisions are consistent with the legislation and based on sound scientific evidence. This is often not easy, but I can honestly say that NRCB staff do a very good job of it."

In addition to board panel reviews of approval officer and inspector decisions, Vern was responsible for six completed public interest reviews of major natural resource projects under the *Natural Resources Conservation Board Act.* The Glacier Power-Dunvegan review involved a joint panel with the Alberta Utilities Commission and Environment Canada under the *Canadian Environmental Assessment Act.*

Vern plans to continue living in Sherwood Park and remain active in community volunteering.

Dust control at feedlots

Southern Alberta's hot and dry summers have been causing dust concerns for many operators and their neighbours. This year NRCB inspectors responded to several dust complaints and worked with the operators to address the nuisance.

Dust is often worst in the evenings, a combined effect of drying manure and increased livestock activity. (Manure tends to be at its driest late in the day, and livestock become more active as the day cools down.) Options for controlling dust include:

- Use a sprinkler system to water pen floors
- Use a water truck to sprinkle pen floors and/or high traffic areas such as feed alleys and access roads, etc.
- Clean feedlot pens frequently (e.g., use a box scraper to remove fine powdery soil from the pens)

Section 20 of AOPA's Standards and Administration Regulation states that the NRCB may require the owner or operator of a CFO or manure storage facility to "use a specific dust...control program at a location occupied by the operation, facility or site." If the NRCB determines that your dust control practice is inadequate, you may be required to change or upgrade the system.

Owners who have a dust control condition in their permit must comply with the condition. Contact your local NRCB office if you aren't sure if your permit has a dust control condition, to confirm what your permit requires or if you require information about dust control methods.



Information sessions for municipalities

AOPA requires approval officers to deny a permit application if it isn't consistent with the land use provisions in the local municipal development plan (MDP). The act also prohibits approval officers from considering MDP provisions that address "tests or conditions" related to the construction of or the site of a CFO, or regarding the land application of manure. However, some MDPs do include tests or conditions, or the land use provisions are unclear, or they conflict with the act. Because of these issues, the NRCB is offering to hold information sessions for municipalities to help them ensure that updates to their MDPs are consistent with AOPA and can be addressed by approval officers in the way the municipality intended.

If an approval officer denies an application on the basis of inconsistency with the MDP's land use provisions, the applicant has the right to request a board panel review. The act does not bind the board to uphold the municipality's land use provisions. If the board determines that there is an appropriate reason to grant the permit, it has discretion to overturn the approval officer's decision. In several recent review decisions, the board overturned the MDP and directed the approval officer to issue the permit.

The NRCB will contact municipalities in early 2018 to arrange for information sessions for council members and administrators.

Policy updates: meat goat CFOs, and CFOs versus seasonal feeding and bedding sites

While an unusual sight in the past, meat goat CFOs are starting to make an appearance in Alberta. (As of 2017, Alberta has eight permitted goat operations.) The management of goats reflects their unique requirements for grazing and housing. To help approval officers (and producers) know whether a meat goat operation is a CFO, the NRCB has produced Operational Guideline 2016-9: *Meat Goat CFO Determinations.* The guideline was developed in consultation with Agriculture and Forestry and Alberta goat producers, and is available on the NRCB website under Operational Policies.

The NRCB is also updating a guide developed in 2015 for distinguishing between seasonal feeding and bedding sites and beef CFOs. As a result of field use and further research and analysis, the update provides more clarity and consistency by including an additional level in the decision tree and a table of factors for assessing facilities that are adjacent to a permitted CFO.

Approval officers, inspectors, and producers can use the guide to clarify when or what part of—an operation needs an AOPA permit. The updated guide will soon be available on the NRCB website under Operational Policies.

On the agenda: October 2017 PAG meeting

The Policy Advisory Group (PAG) will discuss minimum distance separation for category 2 and 4 country residential developments; permit thresholds for liquid manure storage facilities; land use provisions in municipal development plans; and dust control at feedlots.

Application numbers still up in 2017

The NRCB continued to see a high volume of applications in the first half of 2017, due in large part to recent quota increases for the poultry and dairy sectors. With few exceptions, most decisions were issued in fewer than 65 working days from the date the application was determined to be complete.
