

## **Operating Conditions**

### **Schedule A Standard Operating Conditions**

This disposition is subject to and the disposition holder shall comply with, all the provisions and requirements of the document entitled "Northeast Alberta Operating Ground Rules" as amended or replaced from time to time and which is an integral part of this disposition.

Felling, skidding, removal of timber and any necessary site restoration must be completed by the expiry date.

This disposition does not convey ownership of the timber until such time as the timber has been cut for use by the timber disposition holder. Where any inconvenience resulting from the activity of a holder of a land disposition occurs, the timber disposition holder has the right to claim for compensation limited to areas containing the kind, size and species of timber authorized for removal by this disposition.

The disposition holder shall comply with all the provisions and the requirements of;

- a) the Forests Act, and as amended from time to time,
- b) any Act of the Legislature of the Province of Alberta in force, or enacted hereafter from time to time, and as amended for time to time, and
- c) any Regulation inclusive of any amendments or substitutions in force from time to time under any of the Acts referred to in clauses (a) and (b) that apply to the disposition holder or to this disposition either specifically or generally by express wording or by implication.

The Minister may, by notice in writing to the disposition holder, require the disposition holder to provide the Minister, within the time specified in the notice, an audited statement disclosing the information related to the disposition holder's forestry operation that the notice specifies, including, without limitation, information respecting production and sales of primary timber products and reporting of timber dues and levies.

## Operating Conditions

### Schedule B Specific Conditions

The cutting of timber under this permit will be subject to the following conditions:

1. The timber permittee must complete a *Delegation of Signing Authority* form prior to the sale of the timber if the permittee is expecting the purchaser to submit monthly timber returns and royalties on their behalf. Otherwise, the permittee becomes solely responsible for the submission of returns and royalties at the time of delivery of the timber to the purchaser.
2. Prior to commencement of operations, you must contact the following trapper(s) located within the disposition:

All new cut access must be flagged with ribbon and approved as part of the disposition holder's Annual Operating Plan and inspected by a Forest Officer of the Minister prior to clearing.

3. All existing access to be used must be approved in the disposition holder's Annual Operating Plan and if applicable road use agreements shall be obtained.
4. The disposition holder is responsible for the layout of their block boundaries. Cutblock boundaries are to be marked with flagging tape or paint. One corner post, located at the entrance to the cutblock must be marked with a metal tag that indicates the Forestry Division cutblock number.
5. Prior to operations, a pre-start meeting is to be arranged with the designated Forest Officer at the Lac La Biche Forestry Office (780-623-5388) to review operating conditions.

### **Compliance with Federal Legislation**
